


#### 5. Abusive Registration

#### 6. Other factors

I am satisfied that there are no other factors or circumstances present that would render the decision in this matter unfair.

#### 7. Comments (Optional)

Adjudicators are permitted to undertake limited factual research into matters of public record, especially if this is in the interests of justice. See SAIIPL case no. ZA2015-0193. The Adjudicators have independently established that the disputed domain name is listed for sale on a prominent domain name marketplace with a minimum offer price set at \$250. As that likely exceeds the Registrant's reasonable out-of-pocket expenses directly associated with acquiring the disputed domain name, this, combined with the reputation of the Complainant's trade mark and the use to which the disputed domain name has been put, is an additional indicator of abusiveness in terms of Regulation 4(1)(a)(i).

#### 8. Decision

For all the foregoing reasons, in accordance with Regulation 9, we order that the disputed domain name, belgotexcarpets.co.za, be transferred to the Complainant.
