



I am satisfied that there are no other factors or circumstances present that would render the decision in this matter unfair.



Notably, the Second Complainant is also the owner of several domain names incorporating the mark in question, which domain names were further offered as evidence in clause 11.1.4 of the Complaint.

For all the foregoing reasons, in accordance with Regulation 9(1)(a), the Adjudicator orders that the domain name, *prodirectsoccer.co.za* be transferred to the Second Complainant.
